



Traders Rules for the Stamp Exhibition

FILAFAIR REVENUE 2024

Article 1. Definitions

These Rules are applicable for the Stamp Exhibition FILAFAIR REVENUE 2024 in 's-Hertogenbosch, of 5 – 7 September 2024 at “Maaspoort Sportcomplex” in 's-Hertogenbosch, Marathonloop 1, 5235 AA 's-Hertogenbosch the Netherlands. Built up day on September 4, 2024.

The exhibition (approximately 400 till 500 frames) is organized by Stichting Hertogpost at 's-Hertogenbosch, hereafter referenced as organizing committee. The General KNBF Exhibition Rules, the last version is also applicable. Also, inclusive the Dutch version of the “Beursreglement voor deelname FILAFAIR REVENUE 2024 te 's-Hertogenbosch”.

Article 2: The exhibition

The exhibition will be opened: Thursday September 5, 2024 from approximately from 10 o'clock until 4 p.m. Friday September 6, 2024 from 10 o'clock until 4 p.m. and Saturday September 7, 2024 from 10 o'clock until 4 p.m. The construction day is on Wednesday September 4, 2024 from approximately from 2 p.m. until 8 p.m. and on Thursday September 5, 2024 from 7 o'clock until 10 a.m.

The exhibition is a Category / Class 1 and 2 exhibition with national and international Exhibitors & participation. On Friday September 6, there will be a festive “Palmares-evening” (honors list), if sufficient registrations and participation are received on time.

We will inform you after your reservation in what hotel it will be. The fee amounts € 65,00 per person; buffet, refreshing drinks, beer, house wine and inland spirits are included. The number of seats is restricted, so be in time with your reservations. Complete the separate reservation form for this.

Article 3: The Organization Committee

The organizing committee will take care of proper guarding and security. The participants needs to take care of its own insurance. The organizing committee and or its co-workers decline every responsibility for damage, lost or theft, whatever the cause may be.

Article 4: Application and Admission of Stand Participation

Application for stands need to be made in written by letter or mail, preferably before July 1st, 2024. The assignment, the reservation can be made at latest on July 1st, 2024. In the first week of August 2024 at latest, the participation invoices will be sent by email or by post. Payments needs to be pay within 3 weeks from the date of invoice. Your application will be definitive at the receipt of your payment. Admission of a space will be made by the organizing committee. We will reckon with your requests as much as possible.



The official stamp dealers and members of a European stamp dealer organizations will get a special place in event hall of the building. They will get a lockable metal cabinet, wooden or market tables with a tablecloth and five chairs per 4 meters. International auction houses are housed in the custom special NVPH stands. Other stamp dealers or organization will get some wooden or market tables with a tablecloth and three chairs per 2 meters. For your information, there are no along places one of the walls of the venue. Smoking is not allowed inside the building.

It is not allowed to attach anything to the walls which can't be removed without leaving any traces on the wall. The participant is responsible for any damage he might have caused. The stand needs to be empty and clean at the end of the exhibition.

The stand fee will be:

A: Official Traders:

NVPH / European stamp dealer: Price per meter € 110,00 exclusive VAT, inclusive a cabinet & crutches, parking, carpet, a catalogue when it is published and coffee during construction. There is a minimum for reservation of 4 meters. These fees are for the total exhibition time (3 sale days) starting on Wednesday September 4, 2024 (construction day) till Saturday September 7th, 2024 in the afternoon. Parking is free every day.

B: Specialized societies:

One table of 2 meter will be available for promotional purposes of associations, price per two meters: € 55,00 exclusive VAT, under the next mentioned conditions:

- * The table needs to be populated from Thursday up to Saturday inclusive without interruption during opening hours.
- * No trade is allowed, except selling of literature issued by the societies herself.
- * Your application needs to be sent before July 1st, 2024. After this date there is no guaranteed any more for get some place.

C: Other commercial participants

A table of 1 meter is available for € 110,00 exclusive VAT, for this event. (3 days)
The table needs to be populated from Thursday up to Saturday inclusive without interruption during opening hours. Selling of stamps and other things are allowed.

Article 5: Visitors

Youth people till 18 years have a free entry to this event. The price of the catalogue and entry will be communicate at a later moment. If you will advertise in the catalog, full in the form and send it to the organization of Filafair REVENUE 2024 before July 1st, 2024.

Article 6: Stand holders/dealers

The stand holder has sent an application for a stand, has been admitted by the organizing committee and has paid in time, according to the invoice date. Sub tenancy of stands is strictly forbidden. Under no circumstances entry fees for stands will be reimbursed, unless a written withdrawal has been received by the organizing committee, ultimately sixty days before

starting Filafair Revenue 2024. Traders are responsible for their own insurance. There is an alarm system installed with direct report to an alarm center in the hall. Every stand holder will get two free tickets on Thursday morning for entry the event every day.

Article 7: Final provisions

The organizing committee can deviate from these rules in special circumstances if this is not contrary the rules of the KNBF exhibition regulations. In cases in which these regulations have not foreseen, the board of the Stichting Hertogpost decides.

By entering the complex of the “Maaspoort Sportcomplex”, including the parking areas, you agree with the house rules of the “Maaspoort Sportcomplex”. You need to park at the instructions of the organizations.

It is forbidden to park at the loading and unloading doors.

No parking is allowed under any circumstances, precincts even with a disabled parking permit.

Visitors need to comply to all directions given by the organizing committee, its representatives, and the personnel of the “Maaspoort Sportcomplex”. Anyone needing help can get so at request.

Communication by the organizing committee will be exclusively sent by email, unless otherwise needed. This will apply to exhibitors as well as traders, as well volunteers and visitors.

In all cases not covered by these regulations, the organization of Filafair Revenue 2024 decided.

These regulations are established on settled by the board of Stichting Hertogpost on the January 12th, 2024.
